



## Decline –Amex Collision Loss Damage Insurance

I, \_\_\_\_\_ am Member # \_\_\_\_\_ in Enterprise CarShare, and wish to DECLINE the Collision Loss Insurance provided to me when I drive Enterprise CarShare vehicles (excludes cargo branded vehicles) because I have an Amex card eligible for CLDI insurance.

I understand that it is my responsibility to ensure that my Amex card noted below is eligible for the Amex Collision Loss Damage Insurance for “Car Sharing” in the insurance certificate. I also understand it is my responsibility to ensure that I have reviewed and understood the full CLDI insurance coverage details and exemptions as listed in my Cardholders Agreement or Certificate of Insurance.

I understand that I will:

- Retain Third Party Liability, Statutory Accident Benefits, Direct Compensation – Property Damage and Uninsured Automobile coverage provided to Enterprise CarShare members where a deductible may still apply (please see <https://www.entreprisecarshare.ca/gtawelcome> for details.)
- Only retain Collision Insurance provided to Enterprise CarShare members when my reservation is for an Enterprise CarShare branded cargo vehicle; if damage occurs during a reservation in a cargo vehicle, my deductible will be \$250 through Enterprise CarShare’s insurance.
- Pay my Enterprise CarShare reservation estimates, charges and monthly invoice, and any related charges or fines, with my AMEX card noted below
- Be responsible for all damage to the vehicle(s) that I am renting from Enterprise CarShare (to be charged to my AMEX card, and reimbursed as eligible through Amex’s Collision Loss Damage Insurance).
- Inspect the vehicle before and after driving and immediately report any new damage. Failure to report prior damage before driving may result in being held responsible if there is no prior evidence of the damage.
- Report the loss to my credit card company within forty-eight (48) hours of the loss occurring to start a file and obtain a claim number and report claim number to Enterprise CarShare

I hereby authorize Enterprise CarShare to charge my reservation estimates, charges monthly Invoice and any other charges or fees that I incur to my AMEX card. **This card must be on file in your CarShare account. Please confirm this card is on file by logging into your account in the full CarShare site (not on the app).**
